The Saline County Fair Association is sponsoring this event and will provide a \$250 donation towards the scholarship for the 2024 Senior Queen, the remaining \$250 scholarship money will come from paid sponsorship fees. The Senior Queen **must** uphold her responsibilities at the Saline County Fair and fully participate in the Missouri State Fair Queen Contest in order to receive the scholarship.

All contestants must submit an entry form, a parental consent form (if under 18 years), a nominal entry fee of \$10, and a photo to be publicized. Candidates will provide a bio for themselves at the time of registry for the judges and the general public. All Princess, Junior Queen, and Senior Queen candidates will participate in a personal interview with the contest judges the day of the queen contest, time to be announced. All candidates will appear on stage during the evening gown portion of the contest. The Senior Queen Candidates will be required to answer a question on stage during the evening gown portion of the contest.

Candidate Requirements

Little Miss Categories

- Pixie
 - Shall not be less than 3 nor more than 4 years of age on September 1, 2024
 - Must be supervised by a parent or legal guardian at <u>ALL</u> times.
- Sugarplum
 - Shall not be less than 5 nor more than 6 years of age on September 1, 2024
 - Must be supervised by a parent or legal guardian at ALL times.
- Fairy
 - Shall not be less than 7 nor more than 8 years of age on September 1, 2024
 - Must be supervised by a parent or legal guardian at <u>ALL</u> times.
- Royal
 - Shall not be less than 9 nor more than 10 years of age on September 1, 2024.
 - Must be supervised by a parent or legal guardian at ALL times.

Candidate Requirements

Princess Category

- Shall not be less than 11 nor more than 13 years of age on September 1, 2024
- Must be supervised by a parent or legal guardian at <u>ALL</u> times.

Junior Queen Category

- Shall not be less than 14 nor more than 16 years of age on September 1, 2024 Senior Queen Category
 - Shall not be be less than 17 nor more than 22 years of age on September 1, 2024
 - Cannot have been previously selected as Miss Saline County Senior Queen in previous years.

All Candidates

- Candidates shall be female
- Candidates must be a resident of Saline County for not fewer than six months immediately proceedings July 4, 2024.
- Candidates shall be a citizen of the United States and residents of the State of Missouri for not fewer than six months immediately preceding July 4, 2024.
- Shall be members of a Saline County 4-H Club, members of a Saline County FFA or FACS Chapter, or residents of Saline County for not fewer than six months immediately preceding July 4, 2024.
- Candidates shall be single and not cohabitating with a male, or at any time have been married, pregnant, or have a child.
- Candidates must have never been convicted of any crime or have any criminal charges pending.

Dress Code Requirements

- Interview Portion
 - Candidates will wear casual dress clothes (no jeans) to the personal interview portion of the contest.
- Evening Gown Portion
 - Candidates shall wear a formal evening gown during the evening gown portion of the contest.

All entries must be submitted no later than Friday, May 10, 2024.

Late entries will not be accepted!

Additional Requirement for Junior & Senior Queens

- Junior & Senior Queens will reign at the 2024 Saline County Fair and are expected to attend and handle specific responsibilities given by the Saline County Fair Association.
- The 2024 Saline County Senior Queen will represent Saline County in the 2024 Missouri State Fair Queen Contest and will abide by all Missouri State Fair Queen Pageant Rules and Regulations.
