

Saline County Princess Pageant – 2023

Dear 4-H Clover Kids, Elementary School, Kindergarten and PreSchool Parents:

We are pleased to announce that again this year the Saline County Fair Association is sponsoring a Princess Pageant as part of our annual county Queen Contest! The pageant will be held during the Saline County BBQ on Saturday June 3, 2023, on the south side of the Courthouse Square. The winner of the Princess Pageant will represent our fine county at the Saline County Fair.

There is a nominal entry fee of \$2.00 for each contestant, which will help to offset the cost of the event. Payment must be received by no later than Friday, May 19, 2023. Payment shall be made to the “Saline County Fair Association” and mailed to:

Each candidate shall be nominated by a parent, legal guardian, or family member such as grandparent, uncle/aunt/etc, and one nomination per each Saline County 4-H Club. A parent or legal guardian will need to enter their candidate per the instructions on the attached entry form, and also will be required to sign a consent form allowing their candidate to participate.

Parents or legal guardians will provide a bio for their candidate with their registration – this is also the information (except for the contact information) that will be provided to the judges and general public for publicity. All candidates will appear on stage during the formal portion of the contest.

PAGEANT RULES:

- Princess candidates shall be not less than 4 nor more than 7 years of age on September 1, 2023.
- Candidates shall be female.
- Candidates shall be citizens of the United States and residents of the State of Missouri for not fewer than six months immediately preceding July 4, 2023.
- Candidates shall attend an elementary school, kindergarten or preschool within Saline County or be residents of the County of Saline for not fewer than six months immediately preceding July 4, 2023.
- Candidates shall be supervised by a parent or legal guardian at **ALL** times.
- Divisions include: Pixie- 4yrs, Sugarplum- 5yrs, Fairy- 6yrs, Royal- 7yrs

DRESS:

- Candidates shall wear a formal or semi-formal dress during the contest.
