Believing it to be in the best interest of all junior exhibitors to maintain a reputation of integrity and to represent a wholesome and progressive image, Saline County Fair sets forth the following regulation: 4-H and FFA members are expected to conduct themselves according to the best tradition of the perspective organization. Inappropriate conduct (drinking, stealing, vandalism, and indiscreet behavior) will not be tolerated. Any violation of this rule will be grounds for disqualifying the exhibitor and/or livestock involved. Further, any premium monies earned by a disqualified exhibitor will be forfeited.
